Theodore Stampa } Know all men by these presents, that I Theodore Stampa of
the town of Arcadia, Wisconsin party of the first part, in consideration of the sum of Seven (\$10,00) Dollars to me duly paid
and of the other covenants and agreements herein after mentioned, do hereby sell, remise, release and convey, unto John Schmeier and
Frank Slaby, their friends and the public who may wish to use the same as
a road under the conditions and restrictions hereinafter mentioned as
the parties of the second part, and to their heirs and assigns and legal successors
forever for public road, or highway purposes only, the right and privilege
to pass over and through the North West quarter ($\frac{1}{4}$) of the South West quarter
($\frac{1}{4}$) of Section Seven (7) in Township Twenty-one (21) North of Range Nine (9)
that on the following line of survey as the centre of such road or right of
way, to wit: Survey of road on the South West quarter ($\frac{1}{4}$) of South West quarter
($\frac{1}{4}$) of Section 7 - town 21 - range 9, beginning at a white oak tree on
the line of West half ($\frac{1}{2}$) of South West quarter ($\frac{1}{4}$) of Section Seven (7) Township
Twenty-one (21) North of Range nine (9) West, thence North 88 degrees East
7 and 8400 chains, thence North 6 and 1/2 degrees East 3 and 4000 chains
thence South 83^{deg} East 12 chains said road to connect with a road across
Frank Slaby's land, that is over the Northeast quarter of the Southwest
quarter of Section Seven (7) in Township Twenty-one (21) North of Range
Nine (9) West. Said road, passage way or right of way to be 33 feet in
width its entire length, and it is mutually further agreed and under-
stood, and made obligatory upon said Theodore Stampa, Frank
Slaby and John Schmeier the parties hereto using said above road that
a set of suitable gates or bars shall be maintained at and upon all
fifty lines, the same to be erected and thereafter maintained in repair
in equal parts and proportions, share and share alike by said Stampa
Slaby and Schmeier and that said gates or bars so to be maintained
as aforesaid, shall be kept shut by said parties and all others using
the said road, excepting at such time and times as parties shall be
passing over said line and through said gates or bars, and in case of failure
of any party to comply with said condition, he shall be liable to be held
as forfeiting all rights in said road or right of way. Repeated failure to
shut and close said gates or bars as above mentioned by any of the parties
to this contract shall annul, and void his or their rights therein.

In witness whereof, the said Theodore Stampa has hereunto set his hand
and seal this 14 day of May 1889, and the said Frank Slaby and John Schmeier
severally subscribe and accept the above on the terms herein mentioned.
